This list does not include prices for items you have asked us to purchase for you. The prices for those items will also be shown on your statement describing the funeral goods and services you selected.

**“Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.”**

## 1) BASIC SERVICES

Basic Services of Funeral Director, staff and proportionate share of overhead include: Personnel available 24 hours a day/7 days per week to respond to initial call, the arrangement conference with family or other responsible party, coordinating with cemetery, crematory and/or other parties involved in the final disposition of the deceased. Administrative and clerical services, obituary placement; preparation of the death certificate for certification; necessary permits and filing the death certificate with the appropriate agencies. \$1195.00

*This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains)*

## 2) DIRECT CREMATION (alternative container not included) \$1,675.00

Direct Cremation, **without** funeral or memorial services, includes: basic services fee of funeral director and staff, a proportionate share of overhead costs, refrigeration, crematory fee, and transfer of remains to funeral home (*within 30 miles*)

*If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard. The crematory we use accepts only rigid, combustible containers.*

Direct cremation with container selected from our funeral home \$1,810.00 – 1810.00

Direct cremation with container provided by purchaser \$1,675.00

Direct cremation with minimum alternative cardboard container from our funeral home \$1,810.00

Crematory Fee (*up to 250lbs*) \$400.00

Between 250 and 300lb limit (*additional*) \$100.00

## 3) PREPARATION OF THE BODY

EMBALMING: EXCEPT in certain special cases, EMBALMING IS NOT REQUIRED BY LAW

Embalming may be necessary however, if you select certain funeral arrangements, such as a funeral with viewing. If you DO NOT want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, *SUCH AS* direct cremation or immediate burial. \$550.00

## 4) OTHER PREPARATION

Including cosmetology, dressing, positioning in the rental casket \$350.00

Handling of unembalmed remains for *immediate* family viewing (*30 minutes*) \$225.00

Special care for autopsied case or restorative art \$325.00

Dressing (*additional, with or without viewing*) \$175.00

## 5) TRANSPORTATION

Transfer of remains to our mortuary (*within 30 miles*)\* \$475.00

Hearse (*within 30 miles*)\* \$295.00

Service Utility Vehicle/Flower Car (*within 30-miles*)\* \$125.00

*\*Additional mileage fee will be charged at \$3.50 per mile*

## 6) OTHER USE OF FACILITY

Refrigeration: California law requires refrigeration of unembalmed remains, in our care, if cremation or burial does not take place within 24 hours \$450.00  
*If arrangements have not been made after 3 business days, additional \$100.00 a day will apply*

## 7) USE OF EQUIPMENT AND STAFF (M-F ~ 9:00am – 4:00pm)

Use of Equipment and Staff at another Facility for Funeral Ceremony: services include coordination of the funeral ceremony arrangements, supervision of funeral ceremony and staff needed to assist with funeral ceremony. *Additional fee for Evening, Holiday or Saturday service.* \$575.00

Use of Equipment and Staff at another Facility for Memorial Service: services include coordination of the memorial service arrangements, supervision of the memorial service and staff needed to assist with the memorial service. *Additional fee for Evening, Holiday or Saturday service.* \$575.00

Use of Equipment and Staff for Graveside Service: services include coordination with the cemetery for graveside service, supervision, and staff needed to assist. *Additional fee for a Holiday or Saturday service.* \$575.00
